# 30 hours childcare - Top 10 Facts and Information 

FACT ONE:
A 30 hour childcare place is a funded place for up to 30 hours a week for 38 weeks c
the year. If you want a place across school holidays you will have less hours per week. For example taken over 51 weeks of the year you would get 22 hours a week.

## FACT TWO:

Both parents must be in paid work (or the sole parent in a lone parent family) with each parent earning a weekly minimum equivalent to 16 hours at national living wage, and less than $£ 100,000$ per year.

## FACT THREE:

Only the time is funded so your childcare provider can still charge for additional hours, services and consumables such as food, nappies etc. All childcare providers have a charging policy and will be happy to explain charges to you.

## 30 hours childcare - Top 10 Facts and Information

- You should apply for the funding in the term of your child's $3^{\text {rd }}$ birthday (see table) via www.childcarechoices.gov.uk - if you apply too early they might miss the reconfirmation date (every three months), resulting in the code expiring before your child has even taken up their 30 hour place.


## FACT FIVE:

Having a 30 hour code does not mean your child is eligible to start their 30 hour place

| If your child's third birthday falls between | Child becomes eligible for funded place |

| $1^{\text {st }}$ April - $31^{\text {st }}$ August <br> *Think about applying around mid-June Application deadline is 31 August | Autumn Term <br> In the September after their third birthday with a valid 30 hour code issued by 31 August |
| $1^{\text {st }}$ September-31 ${ }^{\text {st }}$ December <br> *Think about applying around mid- October Application deadline is 31 December | Spring Term <br> In the January after their third birthday with a valid 30 hour code issued by 31 December |

## FACT SIX:

A 30 hour childcare place can be taken at a maximum of 2 sites on any one day

## FACT SEVEN:

Childcare Providers need to validate your 30 hour code before they can start your child in a 30 hour place

- Provide your 30 hours (11 digit) code, national insurance number and child's date of birth, to your childcare provider as soon as received.


## FACT EIGHT:

Even if nothing changes in your circumstances you will stop being eligible for a 30 hour place after 3 months unless you reconfirm your details

- The 30 hour code only last 3 months and you need to log back into your Childcare Choices (gateway) account every three months to reconfirm your details. Put a reminder in your mobile phone/device calendar so you do not forget. If your details have not changed, you will only need to tick a box to confirm that the details are the same.

## 30 hours childcare - Top 10 Facts and Information

- Validity periods (reconfirmation dates) will typically be three months. In certain circumstances, the length may vary. If a sibling has previously had the funding, HMRC may shorten the validity period so that it aligns with the older sibling's dates.


## FACT NINE:

It is your responsibility to check the date that you need to reconfirm and make sure that you do this before the deadline.

- All codes are assigned a grace period this is a period of time where the funding will continue even if you are not longer eligible, this is to prevent sudden changes in childcare arrangements, thus giving consistency for you, your child and your childcare provider, this is usually until the end of the next term.


## FACT TEN:

Children cannot take up or transfer a place whilst in their grace period - if you are unsure what this is, please speak to your childcare provider.
